Proposal: Construction of a single storey side, rear extension and front porch. Members agreed to leave this to neighbours observations / comments but wished their concerns over the loss of on-site parking to be noted as they felt this would increase the pressure on parking in the road.

Main Location: Golden Cross Service Station, High Street, Colnbrook,

Proposal: Demolition of existing flat roof side extension and construction of a new two storey side extension and internal alterations.

Despite there being no plans available at this stage Members felt that this site was currently overdeveloped and any further alterations would cause more problems on an already congested and difficult road junction.

### NOTES OF PUBLIC SESSION, TUESDAY 19th May 2015 9.50 pm

A summary of the concerns and issues raised is as follows.

Q. Could the chairman give a statement on the publicity material that was produced in the run up to the elections?

A. The Chairman stated, that in his opinion, the parish council was best represented by people who live and work in the village and a parish council is not the place for party politics. He had concerns that the Labour Party would run the community but don't live here, whereas he had lived in the village for 37 years. He very much hoped that new council would get on and asked for everybody to move forward as the electorate had, had their say

- Q. To the newly elected members, especially those from the Labour Party How do you intend to support members of the village on matters such as SIFE/Heathrow proposed Expansion/Grundon incinerator. Will you support residents or follow the party line and feed Colnbrook to the wolves?
- A. In reply to the above question Cllr Elm-Smith asked what consultation had the parish carried out on proposed Heathrow expansion as he felt that a lot of people were in favour of it as was Slough Borough Council. Consultation should have taken place and everyone should have had their chance to have their say.

With regard to the recent proposed boundary changes, Heathrow will be in Spelthorne Borough who favoured expansion.

Mike Nye commented that the only choice the parish had was to submit comments to the Davis Commission as it was not a planning application. The outcome will be a Government decision and ordinary people cannot object, only respond to the Commission.

Cllr Smith stated that the parish council was a statutory consultee and as such were not obliged to take votes. It had to look at the impact on the area in responding to the planning implications, taking into account loss of green belt, and the traffic, pollution and noise implications. The parish council role is to look after the community assets and only present the facts. It is the M.P's who will make the decision.

- **Q**. Will the new councillors support the residents or the Party Line?
- A. Cllr Elm-Smith stated that he had received 660 votes from residents who supported him

Cllr Richardson stated that the question was not relevant as a councillors primary purpose is for the parish itself not the party line.

Cllr Grewal stated that he was representing the Colnbrook people and supporting them not the party line.
