Main Location: 498, London Road, Slough, SL3 8QX

Proposal: Lawful development certificate for a proposed detached rear outbuilding

Members Objected to this application on grounds of overdevelopment and they had concerns regarding the fire escape route and over the potential to use the outbuilding as a dwelling.

Main Location: Land Adjacent to, 10, Layburn Crescent, Slough, SL3 8QN Proposal: Construction of a detached two storey (3 bedroom) dwelling house with amenity 1 car parking provision and associated works.

Members Objected to this application on grounds of overdevelopment and that the open green space is being eroded. There were also queries as to if the correct allowance for cark parking spaces had been provided.

Main Location: **18b, Springfield Road, Slough, SL3 8QJ** Proposal: Construction of a single storey rear extension **Members had No Objection to this application.** 

Planning Application Ref: P/11658/010

Main Location: Land At Coleridge Crescent & Adj To, Hadley Court, Colnbrook, Slough

Proposal: Approval of Condition 10 (landscaping) pursuant to approved outline Planning Application P/11659/008 dated 17 June 2015

Members had concerns that there were no plans available on the Borough planning portal in time for the meeting.

Concerns were expressed over the piece of land down the side of the site which had been original designated as open space and queried if this will be maintained by the Borough Council – Please confirm.

Members also wished to receive answers to the questions asked back in April 2015, namely.

- 1. Are there sufficient car parking spaces allocated on site?
- 2. Would there be any over looking into the adjacent properties in Hadley Court?
- 3. Who would maintain the front landscaping, and the external grass area around the site? If just left, these areas would become unkempt.
- 4. The access drive appears to be very close to the road junction at the corner of Rodney way with Coleridge Crescent and as such may have sight line problems.
- 5. Who would be responsible for the small area of Public Open Space? Would Slough Borough Council adopt this area since again there would be maintenance issues.

Please provide these answers.

Members asked for clarification as to what B2, Genaral Industrial, covers and could the applicant be more specific.

### PC/16/044 ANNUAL PLAY INSPECTION

The clerk updated members on the background and repairs carried out.

Cllr Angell to contact SBC to check the condition of other zip wires to enable a comparison to be made to CPPC.

It was noted that little money had been spent on the play area in the last few years and that it needed to be fit for use.

Cllr Angell commented that Albany and Crown Meadow were to be upgraded by SBC and it was agreed to go out for quotations for repairs/replacements.

He also commented on the 'Green Flag' in that there is a small fee for this but the play areas still needed to be maintained.

### PC/16/045 CHAIRMAN'S CORRESPONDENCE

The Clerk reported receipt of correspondence from TVP in relation to Torridge Way, the parish council to monitor and offer help and the Clerk to reply regarding catapults.

The Clerk had received the completed Annual Return from Mazars, this to be advertised on the notice boards.

#### PC/16/046 AREAS OF RESPONSIBILITIES

Cllr Richardson – Attended Local Access Forum, discussed was:-

South Bucks Local Plan and the pressure on Green Belt due to planning. Re: Consultation documents rep's being sought to protect local network adjacent to Slough.

Colnbrook disused railway – improving safety, better width and surfacing. LAF had objected to an application for development and asked that it be listed in the Local Plan as an area restricted to nature reserve with public access.

Poyle new cottages have Right of Way land, private route blocked. Needs to be claimed back as a 'Public Right of Way'. Clerk to contact Jackie Wheeler.

Cllr Angell – Attended AGM of CVHT. He asked all Councillors to attend the Apple Fair on the 17<sup>th</sup> September. Cllr Bryant suggested any members available to help email Cllr Hood.

 $Cllr\ Bedi-NAG\ meetings$  to be moved to accommodate TVP but move back to a meeting every 4 weeks.

FAG – regular walkabouts and meetings. A multi-agency meeting has been set up for November.

Cllr Kinane – Need 3 weirs in Horton Brook to retain water for fish. EA to ask landowners if they will do and fence from the recreation ground to the ditch.

Comment from Mike Nye – The EA have a national policy to remove weirs on private land.

Cllr Bedi – Costa Coffee agent still interested in the Star and Garta and have agreed to meet and give him support.

Doctors surgery forum – residents did turn up to the meeting and the  $2^{nd}$  forum will be on the  $10^{th}$  September and it was requested that councillors attended this and show support.

Cllr Bryant commented on the following:

- Cllr Smith/Brook survey with community to ask for feedback and report back at the next services committee.
- Web site page promote recreation ground and how progressed
- Memorial Plaque has been destroyed, Shaws Trophy has kindly donated a replacement.
- Parish Forum is to be held on Saturday 1<sup>st</sup> October, which is an event hosted by the Parish Council for the organisations in Colnbrook to get together and engage with the community
- Cllr Elum-Smith accepted the War Memorial project, following on from residents' concerns over the recent vandalism of the current memorial. The project is to engage with residents to find out what they would like and the location. The Parish Forum is a good opportunity for Cllr Elum-Smith to start the engagement with residents.
- Met TVP, they will try to turn up at drop in sessions (01.10.16) and at the Apple Fair.

TVP looked at CCTV in relation to burglaries at 'Colridge End'.

  - i) Speed bumps by Ostrich been replaced, now asking for rest to be done.
  - ii) London Road accidents contacted SBC/TVP
  - iii) Cllr Brooks accepted focus on London Road to look at how to make it safer.
  - iv) Parking issues at Pippin School Asked for 2 yellow lines to stop parking on corners and remark school lines.
  - v) Repainting Village Hall car park chased up.
  - vi) Inappropriate parking SBC informed L&P will chase up.
  - vii) High Street cleaning asked for barrow/broom to start at Punch Bowl to SJ Homes.
  - viii) Roads remarked, street signs cleaned and drains unblocked. Bins need emptying.
  - ix) Layby's used as toilets, request that SBC close them off.
  - x) Overhanging trees reported to SBC, photo's to be taken.
  - xi) Grass cutting/waste collection when cut back exposes litter, needs to be done at same time.
  - xii) Springfield to Crown Meadow photos sent and floods/mud where rains collects.
  - xiii) Ragwort reported and chased up.
  - xiv) Horse behind residence in Brands Hill PCSO aware of owner and has asked them to keep clean and tidy and properly fenced.
