Resident concerned about police lack of activity.</p> <p>Thames Valley Police update that Street Surgeries starting in New Year. Cllr Kinane informed about Drug Users in Recreational Ground. Police will be invited by the Parish to discuss the possibility of Future Partnership with Street Surgeries. Chair believes it works quite well. On a whole Burglaries are down. Criminal Vandalism is up. On a whole positive for Colnbrook regarding Crime. Completed High visisble patrols around the Parish.</p> <p>Resident asked if figures low cause no one reporting. Police are trying to get people talking via street surgeries. Cllr Lever feels residents need to see the Police more and knocking on doors. The police have started door knocking around the Parish.
